Criteria policy

Eligible Projects

- **Ministry needs**
- **Personal / family need**

Eligibility requirements

- Christian leaders in Canada who works a minimum of 35 hours per week in the ministry OR person(s) / organizations involved in church planting globally
- Person(s)/organization is not in bankruptcy or in insolvency.
- Person(s)/organizations on the Canadian terrorism watch-list will not be eligible.
- Willing and able to provide reports regarding the project as stipulated on grant approval.

Proof required

1. Funds must go from Providence 4 Missions to a joint ministry partner or others as applicable preferably not directly to individuals.
2. Proof of valid organization registration in the country of application.
3. The applicant must show clear evidence of a compelling need with supporting documents example financial statement etc.
4. All documentation must be dated for the year in which the application is made. Providence 4 Missions will not provide multiple year funding for projects or roll projects over from year to year.
5. Projects that only include research activities, with no impact on leader and/or family and /or ministry are not eligible.
6. Proof of project sustainability if applicable.
